- 2. NEET-UG 2025 qualified candidates who have not registered in the previous round(s) are allowed to register and fill in their "Seat Choices" in the web-based application to participate in the 2nd Round of the Manipur Medical eCounselling 2025-26 as per schedules given above. Link to the web-based application is also available on this Directorate website https://manipurhealthdirectorate.mn.gov.in. Before registering in the web application, candidates shall carefully read the "General Instructions for Registration" and "Technical Instructions for Registration" notified vide this Directorate notification of even No. dated 28-07-2025 and 29-07-2025 respectively.
- 3. The 2nd round of eCounselling for allotment of Management quota seats at SAHS is kept on hold until further notice to avoid legal complicacies.
- 4. Registration will be complete only after payment of the following 02 (two) kinds of Fees:
 - a. Non-refundable Application Fees as follows:
 - (i) ₹ 2000/- (₹ 1500/- for ST and SC candidates) for State Government seats.
 - (ii) ₹ 2000/- for Management & NRI quota seats at SAHS.
 - (iii) ₹4000/- (₹3500/- for ST & SC candidates) for both Government and Management / NRI guota Seats.
 - b. Refundable Security Fees of ₹ 5000/- for all categories. This amount shall be refunded after completion of all rounds of counselling.

No fees shall be separately charged for "Choice Filling" in the web application.

- 5. Registered candidates shall carefully read the "Technical Instructions for Choice-filling" given as Annexure A before filling in their "Seat Choices" in the web application.
- 6. Merit list of candidates for the 2nd Round of the eCounselling shall be prepared from the candidates who have successfully filled in their "Seat Choices" for the 2nd Round of the eCounselling as above. "Choice of seat" filled in any round will not be valid for further rounds.
- 7. Candidates who have joined the seats allotted in the 1st Round of eCounselling shall be included in the Merit List for the 2nd Round only after uploading the "NOC" in the prescribed format while filling in their "Seat Choices" in the web application. If a candidate is allotted a new seat in the 2nd Round, the seat previously allotted to the said candidate in the 1st Round shall be deemed to be vacant and shall be allotted to another candidate in the 2nd Round itself.
- 8. The available seats in the 2nd Round of e-Counselling shall be notified later.
