No.104/1/2025-DHS: Candidates registered for Manipur Medical eCounselling 2025-26 shall compulsorily fill in "Seat Choices" in the web App <https://manipurmc.mn.gov.in> to participate in the 2nd Special Stray Round of the eCounselling for allotment of State Government quota seat for BDS course at JNIMS as per schedule given below:

2. NEET-UG 2025 qualified candidates who have not registered in previous rounds are allowed "to register" and fill in "Seat choices" in the web App to participate in 2nd Special Stray Round of Manipur Medical eCounselling 2025-26 as per the schedules. Link to the web App is also available in this Directorate website <https://manipurhealthdirectorate.mn.gov.in>. Before registering in the web App, candidates shall carefully read the "General Instructions for Registration" and "Technical Instructions for Registration" given in this Directorate notification of even No. dated 28-07-2025 and 29-07-2025 respectively.

3. Registration will be complete after payment of the following 02(two) kinds of Fees:

- Non-refundable Application Fees as follows:
 - ₹ 2000/- (₹ 1500/- for ST and SC candidates) for State Government seats.
 - ₹ 2000/- for Management & NRI quota seats at SAHS.
 - ₹ 4000/- (₹ 3500/- for ST & SC candidates) for both Government and Management / NRI quota Seats.
- Refundable Security Fees of ₹ 5000/- for all categories. This amount shall be refunded after completion of all rounds of eCounselling.

No fees shall be separately charged for "Choice Filling" in the web App.

4. Registered candidates shall carefully read the "Technical Instructions for Choice-filling" given in this Directorate notification No. DHS-304(1)/4/2025-DHS-DHS dated 13-10-2025 before filling in "Seat Choices" in the web App.

5. Merit list of candidates for the 2nd Special Stray Round of eCounselling shall be prepared from the candidates who have successfully filled in "Seat Choices" for the 2nd Special Stray Round of eCounselling as above. "Choice of seat" filled in any round will not be valid for further rounds.

6. Following categories of candidates are **NOT ELIGIBLE** for 2nd Special Stray Round-

- Candidate joined/holding any seat at the time of 2nd Special Stray Round.
- Candidates allotted a seat in 3rd, Stray vacancy and Special Stray Vacancy Rounds of eCounselling and NOT REPORTED



7. If a candidate does not report after getting a seat allotted in 2nd Special Stray Round, he/she will be forfeited of the security deposit and will be eliminated from further rounds of eCounselling, if any

8. The available seats of State Government Quota in the 2nd Special Stray Round of eCounselling is enclosed as Annexure A.
